In signing this application, I verify that I have boating liability insurance in the amount of at least \$100,000. By my signature, I have read and understand the rules and the agreement provided by Iowa Premier Bass LLC. Entry forms that are not completed in full and signed by both parties will not be accepted. Fill out completely, sign, include payment and mail to address shown. A minimum \$500 deposit is required to secure a roster spot. Registrations and full payment received by January 31st are entered into the series. Full payment of \$1500 for the season includes 6 elite tournaments. Big bass entry is included in tournament payment. Tournament waters are off limit at 5pm the day before a tournament begins and after weighin during a two day tournament. Boat numbers will be drawn the day before each tournament via randomresult.com. Start time is safelight. Teams are expected to fish all events. Substitues are to be identified at time of registration and at the discretion of the director.
