In signing this application, I verify that I have boating liability insurance in the amount of at least \$100,000. **By my signature, I have read and understand the rules and the agreement provided by Iowa Premier Bass LLC.** Entry forms that are not completed in full and signed by both parties will not be accepted. Fill out completely, sign, include payment and mail to address shown. A minimum \$200 deposit plus \$30 membership fee is required to secure a roster spot. Only registrations and full payment recieved one week prior to the first tournament fished are entered into the tournaments. Big bass entry is included in tournament payment.

Tournament waters are off limit at 5 days prior to one day events, 5pm the day before 2 day events, and after weighin during a 2 day event. Boat numbers will be drawn the day before each tournament via randomresult.com. **Start time is safelight.** Substitues are to be identified at time of registration and at the discretion of the director.
